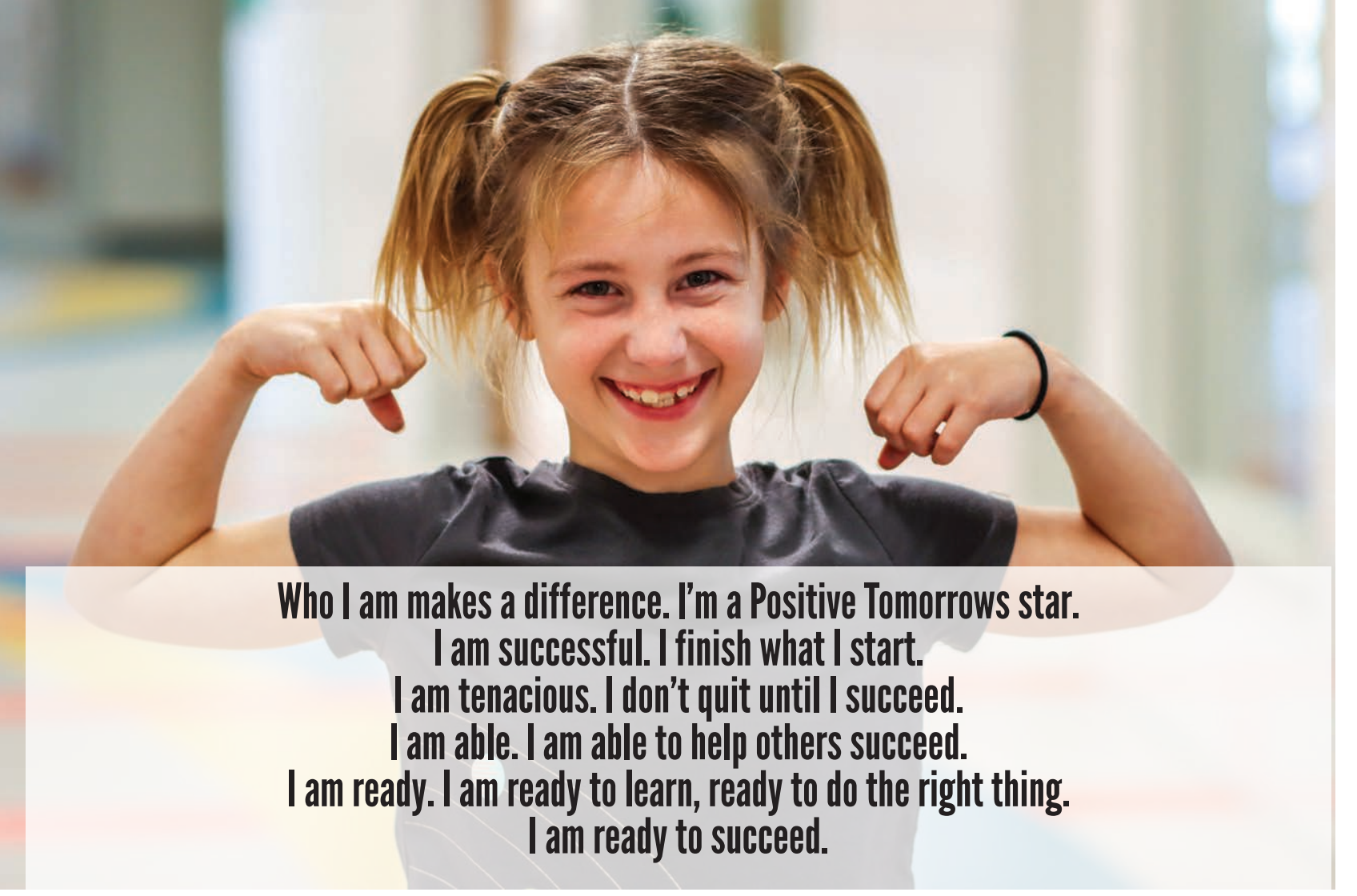

What does success look like? In this report, you'll see a lot of data that shows the accomplishments of our kiddos and families. They're your standard measures of success, but numbers alone sometimes don't do justice to the life changing stories behind them.

What you don't see in the numbers here is the smile on the kiddo's face who just earned four certificates for advancing multiple levels in their reading program. The pride and self-confidence they build with each gain adds to the sense of safety and security they were already feeling because mom just got a new job, and their housing voucher just came through. This means a new apartment will be next, and it will be soon. You're not seeing the tenacity of our families. With each move from car to shelter to couch to an apartment, they still make sure their kiddos get to school each day.

The numbers tell you about the pairs of glasses and doctor visits. But they don't tell you that being able to see means you finally have all the tools you need to learn to read. And how now that you have a prescription for an inhaler to keep your asthma under control, you don't have to be scared to participate in PE.

This annual report is representative of new beginnings for the 665 individuals we served this year. You give our staff the tools and support to provide each family and each precious kiddo an opportunity to be successful. That opportunity is the greatest gift. We are grateful.

Positive Tomorrows is Oklahoma's only school and social service agency specifically for children and families experiencing homelessness. We help students and families to succeed, and we do it in three main ways:

1. By breaking down barriers to learning like hunger, lack of basic necessities, medical care, and transportation.
2. By supporting families so they can improve their housing, employment and overall quality of life.
3. By providing a differentiated, trauma-informed education to every student, complete with enriching, extracurricular opportunities.

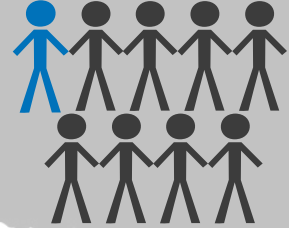

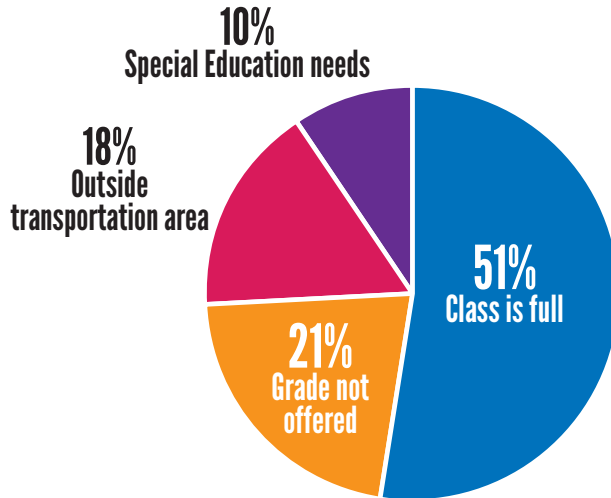

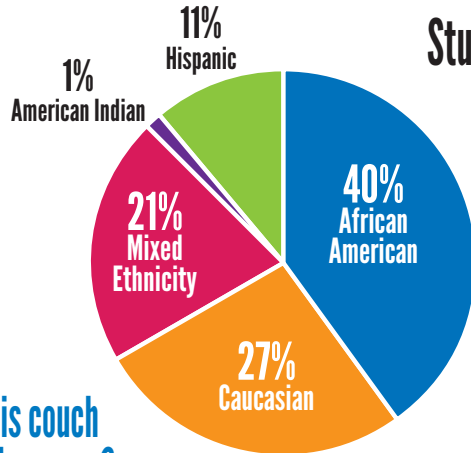
Why are students turned away?

Student Demographics



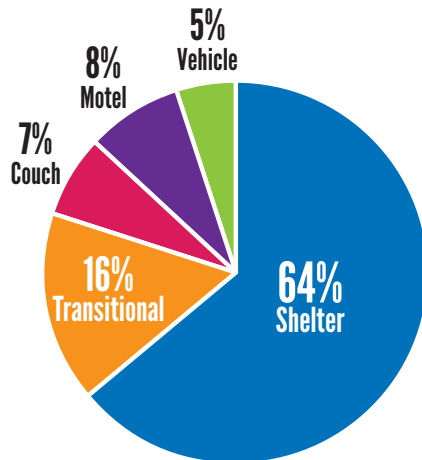
What is couch homelessness?

Being couch homeless doesn't always mean sleeping on a couch. These students call a different place home every night. They may double up with other families in a shared dwelling with makeshift sleeping arrangements.

Other situations our families may face before coming to us include bouncing around unsafe motels or even spending nights in the family vehicle.

These categories are typically the most unstable situations for a student.

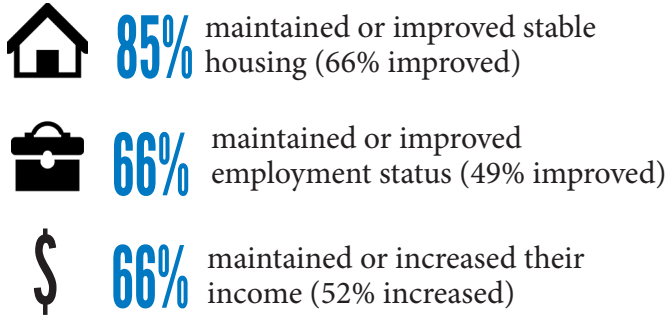
Student Housing at Point of Enrollment

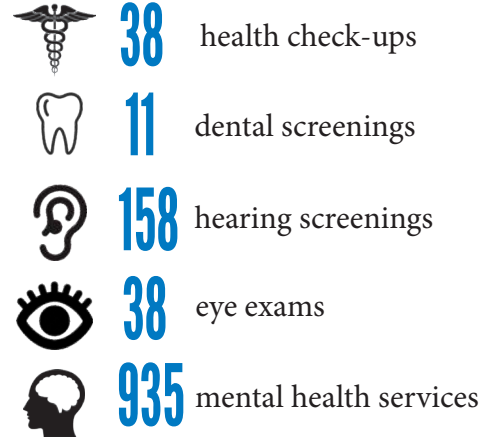

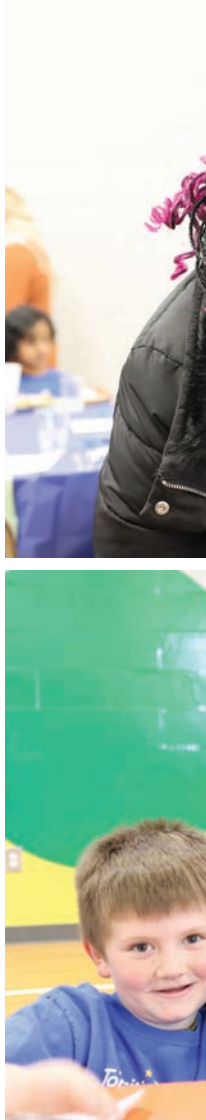
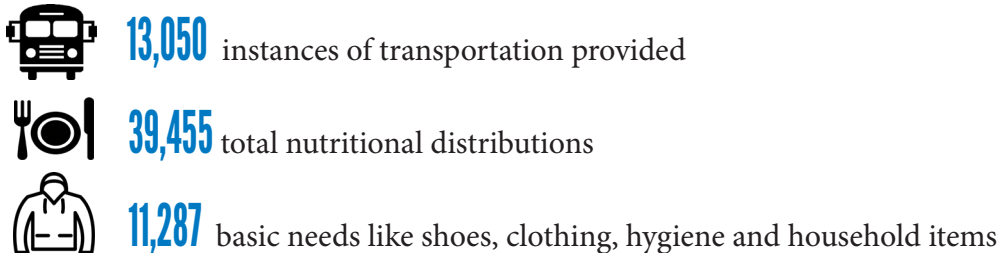

Students participate in daily after-school activities. During school breaks - fall, winter, spring, and summer - day camps ensure students continue to learn and grow. Former students are also invited to attend break camps as a resource for our transitioned families. Our extracurricular program served a total of **225 unduplicated students**.

Evaluating our Program

Positive Tomorrows assesses students using a tool called the Measures of Academic Progress (MAPs) assessment, which focuses on individual student growth.

MAPs assessments are designed to be given three times during the year for continuing students and upon entry and withdrawal for students only here a short time. Because enrollment fluctuates considerably at Positive Tomorrows, not all students can be assessed more than once due to their length of stay.



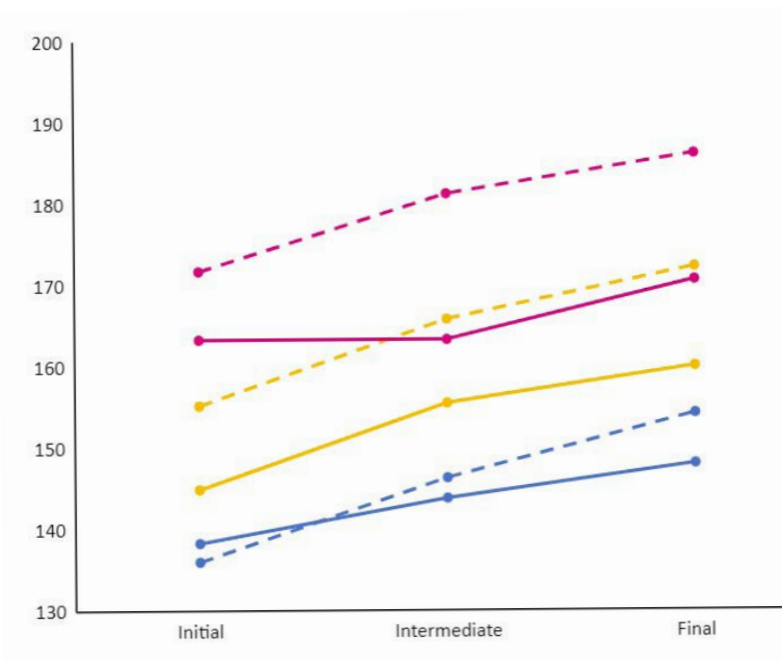
Interpreting Results

In MAPs, improvement is measured in Rausch Units, or RITs. RIT scores allow students to be accurately measured regardless of their grade level. The RIT scale uses equal intervals, and it has the same meaning regardless of grade level, so the RIT scale spans grades.

In order to evaluate RIT scores within a context, RIT Scale Norms have been developed that show what students in various grades are achieving nationally. The mean RIT Scale Student Achievement Norms for the corresponding grade levels are represented with dotted lines on the following graphs. The average Positive Tomorrows student RIT score growth is represented by a solid line for each grade level.

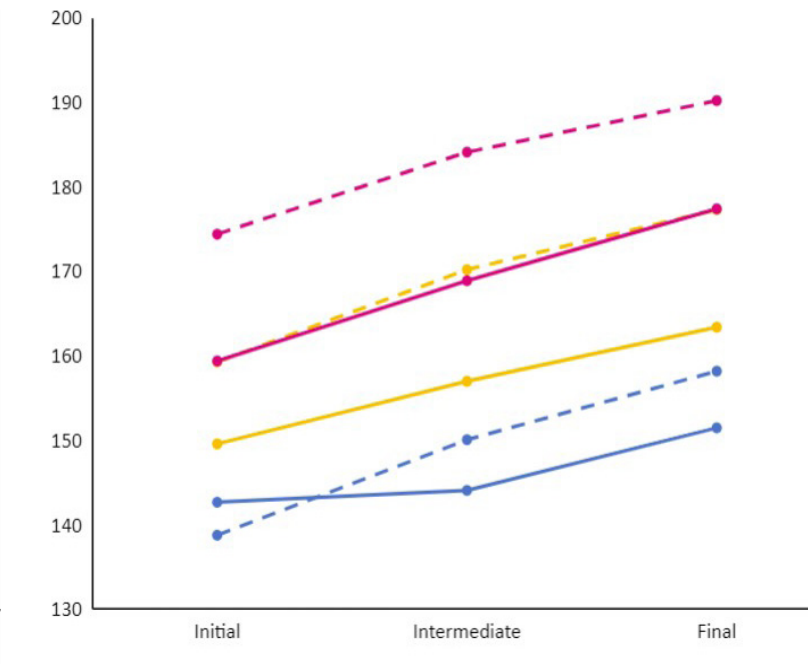

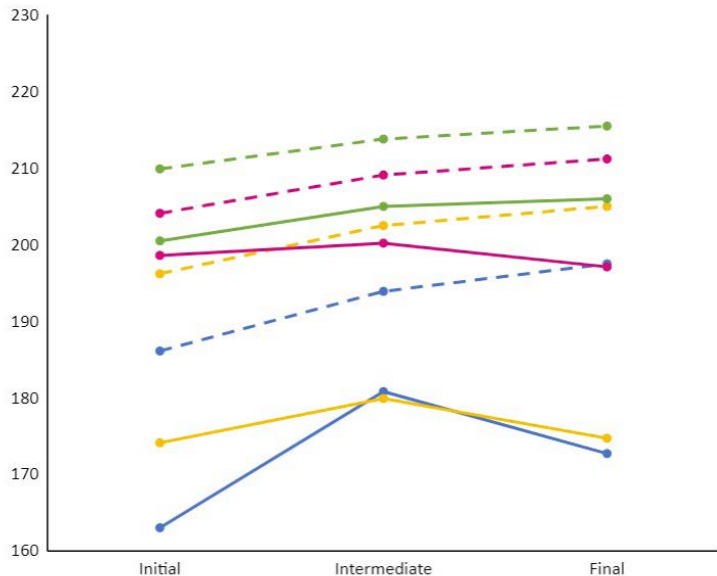

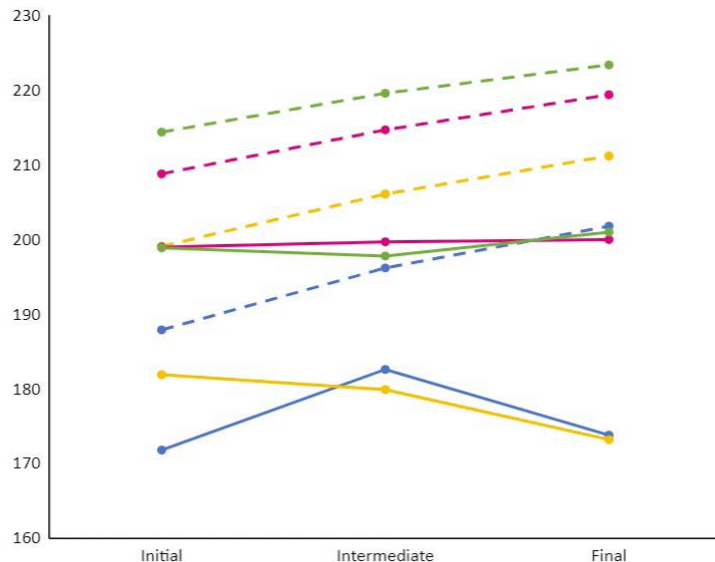

Mobility, Trauma and Tracking Progress

The trauma of homelessness almost always impacts academic growth. Children who face disruptive environments and frequent residential changes are at a greater risk for academic and behavioral challenges. For some of our students, simply maintaining their academic levels during trauma they experience is success.

The 2021-2022 school year at Positive Tomorrows served more students than the previous year due to the median length of time a student was enrolled decreasing from 106 to 77 days.

The decrease in length of time enrolled does not mean families dropped off our radar. This year, we were able to help more families than ever with emergency housing assistance. Unfortunately, the lack of affordable housing in our community sometimes means families must move out of our transportation area in order to find a safe place to live, impacting the length of time families are enrolled at Positive Tomorrows.

Case managers are actively working to develop additional ways to address challenges for families transitioning out of homelessness, including building partnerships with property managers and educating landlords about accepting housing vouchers. Household stability is the foundation for successful engagement in school.

Housing Assistance

A safe and stable home is a foundation all children and families need and deserve.

Positive Tomorrows Family Support team leverages key partnerships and funding sources to secure housing, prevent homelessness and keep families off the street.

Through generous donations to our housing fund, and participation in innovative funding solutions like the Emergency Food and Shelter Program and the Emergency Solutions Grant, we were able to help more families maintain housing stability by strategically paying move-in costs, rent, utility bills and emergency motel stays for families in crisis.

This year, Positive Tomorrows was one of three local agencies to access COVID-specific emergency housing vouchers through the Oklahoma Housing Finance Agency, helping 115 households obtain Section 8 vouchers, and securing homes for 70 unhoused families.

Families on the cusp of regression, whether due to a crisis or upfront expenses for new housing, were able to see these potential barriers through to the other side and continue their path to stability.



Rehousing or eviction prevention assistance was provided to
65 PT households. **90%** secured housing or remained housed
without experiencing another instance of homelessness.

Self Sufficiency Matrix

The Self-Sufficiency Matrix (SSM) is an evidence-based assessment and outcomes measurement tool that documents progress toward self-sufficiency across a variety of domains. The tool helps provide a holistic view of the many different circumstances that contribute to each family's situation. It also helps us measure impact as families move toward stability and economic security.

As the experts in their own lives, families take the lead in setting goals for themselves. We meet every family where they are and work with them to develop an individualized plan that meets the family's needs and builds on their existing strengths.

59 Positive Tomorrows clients were evaluated using the SSM at the time of their enrollment and upon completion or exit from the program, with an average **30% increase in self-sufficiency** across 17 life domains.
