Who We Are

Positive Tomorrows is Oklahoma's only school and social service agency specifically for families experiencing homelessness. We help children and families to succeed, and we do it in three main ways:

1. By breaking down barriers to learning like hunger, lack of basic necessities, medical care and transportation.
2. By supporting families so they can improve their housing, employment and overall quality of life.
3. By providing a differentiated, trauma-informed education to every student, complete with enriching, extracurricular opportunities.

Positive Tomorrows Pathway

ENROLLMENT



To qualify for enrollment, a family must be living in one of the following situations: emergency shelter, transitional housing, vehicle, campground, motel, or temporarily sharing the housing of others.

We offer trauma-informed education with small class sizes, transportation, break camps, after-school programs and extracurricular opportunities, all designed to remove barriers to learning.



EDUCATION

FAMILY SUPPORT



Simultaneously, each family has a case manager who supports them as they identify their needs and strengths in order to achieve their personal goals.

Family stability is the foundation for successful engagement in school.

We identify students' needs through on-site evaluations and screenings, connecting them with resources like glasses and counseling, or with referral based services like speech, occupational therapy, etc.

By accessing these services during the school day, we remove barriers like transportation and scheduling, ensuring families can focus on stability while students get the care they need to thrive.



HEALTHCARE & SUPPORT SERVICES

Success looks different for everyone. We see the most significant impacts among families who stay in our program for 1-2 years.

On average, we are able to help families secure stable housing within 3-6 months after enrollment.

We provide both rapid re-housing and eviction prevention programs.


After about a year and a half of enrollment, when kids are up to speed academically and socially, and families have had stable employment, transportation, and housing for six months or more, families are introduced to our Transition Coordinator to start making a plan for what's next.

Each spring we host a graduation ceremony to recognize the success of our transitioning families and celebrate their success together as a school community!

Students who have graduated from Positive Tomorrows are invited back to attend break camps and parents often come back to attend peer groups, participate in our community, or provide program advisement.




Why are students turned away?

Student Demographics





What is couch homelessness?

Being couch homeless doesn't always mean sleeping on a couch. These students call a different place home every night. They may double up with other families in a shared dwelling with makeshift sleeping arrangements.

Other situations our families may face before coming to us include bouncing around unsafe motels or even spending nights in the family vehicle.

These categories are typically the most unstable situations for a student.



We believe any interventions to reduce family homelessness must combine services for children and parents with housing assistance. Quality education, employment support and therapeutic services must go hand-in-hand with housing to create lasting stability.

Thanks to generous family foundations and private donors, and through collaboration with other non-profits, Positive Tomorrows can help cover move-in costs, rent, utilities and emergency motel stays for families in crisis, ensuring setbacks don't derail their path to stability.



Students participate in daily after-school activities driven by student choice.

During school breaks - fall, winter, spring, and summer - day camps ensure students continue to learn, grow, and avoid the academic summer slide. Former students are also invited to attend break camps as a resource for our transitioned families.

Evaluating our Program

Positive Tomorrows assesses students using a tool called the Measures of Academic Progress (MAPs) assessment, which focuses on individual student growth.

MAPs assessments are designed to be given three times during the year for continuing students and upon entry and withdrawal for students only here a short time. Because enrollment fluctuates considerably at Positive Tomorrows, not all students can be assessed more than once due to their length of stay.




Interpreting Results

In MAPs, improvement is measured in Rausch Units, or RITs. RIT scores allow students to be accurately measured regardless of their grade level. The RIT scale uses equal intervals, and it has the same meaning regardless of grade level, so the RIT scale spans grades.


In order to evaluate RIT scores within a context, RIT Scale Norms have been developed that show what students in various grades are achieving nationally. The mean RIT Scale Student Achievement Norms for the corresponding grade levels are represented with dotted lines in the graphs on the following pages. The average Positive Tomorrows student RIT score growth is represented by a solid line for each grade level.

K - 3rd Grade Reading Growth




K - 3rd Grade Math Growth




Academic Improvement: 4th - 7th Grade
